## Release, Waiver and Assumption of Risk Agreement

I hereby acknowledge and agree that in consideration of being permitted to participate in the snowmobile programs or activities organized, operated or sanctioned by the Whitecourt Trailblazers Snowmobile Club, its members, officers, directors, employees, independent contractors, and agents (hereinafter referred to as "the Club"):

- 1. I do hereby release, the Club from all liability, and do hereby waive as against the Club all recourse, claims, or causes of action of any kind whatsoever, in respect to all personal injuries or property losses which I may suffer arising out of or connected with my preparation for, or participation in the aforesaid snowmobile programs or activities, notwithstanding that such injuries or losses may have been caused solely or partly by the negligence of the Club.
- 2. And, I hereby acknowledge and that:
  - a. The sport of snowmobiling is dangerous, exposing participants to many risks and hazards, some of which are inherent in the very nature of the sport itself, others which result from human error and negligence on the part of persons involved in preparing, organizing and staging snowmobile competitions and other activities;
  - b. As a result of the aforesaid risks and hazards, I as a participant may suffer serious personal injury, even death, as well as property loss;
  - c. Some of the aforesaid risks and hazards are foreseeable, but others are not;
  - d. I nevertheless freely and voluntarily assume all the aforesaid risks and hazards, and that, accordingly my preparation for, and participation in the aforesaid snowmobile programs and activities shall be entirely at my own risk;
  - e. I understand that the Club does not assume any responsibility whatsoever for my safety during the course of my preparation for or participation in the aforesaid snowmobile programs and activities;
  - f. That I have carefully read this RELEASE, WAIVER AND ASSUMPTION OF RISK agreement, that I fully understand same, and that I am freely and voluntarily executing same;
  - g. I understand clearly that by signing the Release, I will be forever prevented from suing or otherwise claiming against the Club for any loss or damage connected with any property loss or personal injury that I may sustain while participating in or preparing for any of the above mentioned snowmobile programs or activities whether or not such loss or injury is caused solely or partly by the NEGLIGENCE of the Club;
  - h. I understand clearly that the Club would not permit me to participate in any such snowmobile programs or activities unless I signed this RELEASE, WAIVER AND ASSUMPTION OF RISK agreement, that this RELEASE, WAIVER AND ASSUMPTION OF RISK agreement applies to all of the aforesaid snowmobile programs and activities whether occurring in the near or distant future, and that the terms of the Agreement need not be brought to my attention each time I participate in such program or activity in order to be effective;
  - i. This RELEASE, WAIVER AND ASSUMPTION OF RISK agreement is binding on myself, my heirs, my executors, administrators, personal representatives and assigns; and
  - j. I understand clearly the Club is and shall be deemed to be acting for itself and as agent on behalf of and for the benefit of the members, officers, directors, employees, independent contractors, and agents of the Club for the purposes set out in the above-stated clauses of this agreement.
  - k. No oral representations, statements or inducements apart from the foregoing written agreement have been made.
